### **A. Terms and Conditions**

These Terms and Conditions (the "Terms and Conditions") relates to the Promotion offered by ICICI Bank UK PLC for a period of 1 year, your participation in the Promotion is governed by these Terms and Conditions.

These Terms and Conditions are in addition to, and not in derogation of the Personal Banking Terms and Conditions and Safe Deposit Box Agreement and application available on website. If there is any inconsistency between the Personal Banking Terms and Conditions and Safe Deposit Box Agreement and Application, then these Terms and Conditions shall prevail.

### **B. Definitions:**

The words "**we**", "**us**", "**our**" and words with similar meaning refer to ICICI Bank UK PLC. By participating in the Promotion, you agree to be bound by these Terms and Conditions, which may be amended, modified or supplemented at any time by us. Any changes in the Terms and Conditions will be made available and updated on our website.

In these Terms and Conditions, unless otherwise defined, capitalised terms shall have the meaning as assigned to them below:

**"SDB"** means Safe Deposit Box available in Harrow and Wembley branch.

**"Home Vantage Current Account (HVCA)"** means Personal Current Account.

**"Branch(es)"** refers to the branch offices of ICICI Bank UK PLC in the United Kingdom.

**“Rent”** refers to the rent that will be charged and collected upfront from the active bank account based on the selected SDB type.

**“Entrant”** refers to a person applying for a new SDB or holding existing SDB service with ICICI Bank UK PLC.

**“Promotion Period”** refers to the period of the Promotion starting from June 01, 2021 to May 31, 2022

**“Security Deposit”** The Lien will be marked to the minimum amount agreed in the

Agreement for a period till the validity of the Agreement; the Hirer/s will be required to keep their ICICI Bank UK PLC account opened for the duration of the Term. If there is any unpaid hire after sending written notice, it will be recovered from the security deposit amount which is marked Lien in your ICICI BANK UK PLC current account

## **D. Detailed Terms**

### **1. New SDB customer**

- a. The Entrant holding a HVCA with ICICI Bank UK PLC, will be eligible for 50% discount on rent during the Promotion period.
- b. The rent and security deposit for the SDB to be collected only from HVCA

### **2. New SDB Customer successfully opening NRI account during promotion period or holding existing NRI account**

- a. The Entrant holding a HVCA with ICICI Bank UK PLC, will be eligible for 100% Discount on the rent for 1<sup>st</sup> year. The Entrant must successfully open a NRI account or hold an existing NRI account
- b. The rent and security deposit for the SDB to be collected only from HVCA

### **3. Existing SDB Customer successfully opening NRI account during promotion period**

- a. The Entrant holding a HVCA with ICICI Bank UK PLC, will be eligible for 100% Discount on the rent for 1<sup>st</sup> year. The Entrant must successfully open NRI account and the subsequent rent due date must fall within the Promotion Period.

### 6. Do I have to keep a security deposit for a Safe Deposit Box?

Yes, you are still required to keep the security deposit for holding the Safe Deposit Box in Harrow and Wembley branch as per the above table.

## **7. What are the requirements to apply for a Safe Deposit Box with the Bank?**

You should hold a HomeVantage current account with the Bank and have sufficient funds in the account to cover the annual rent that will be taken upfront and the security deposit that will be lien marked. You will also need to provide a valid identity proof and one photograph of each holder/s.

## **8. Which Terms and Conditions will apply after the promotion period on Safe Deposit Box?**

Discount on Safe Deposit Box Rental charges is available for one year ONLY. Post completion of the Promotion period, the prevailing Safe Deposit Box rental charges will apply as per the prevailing Terms and Conditions specified in the Safe Deposit Box Agreement and Application.

## **10. Will I be eligible for this promotion if I hold only Non-Resident Fixed Deposit/ Foreign Currency Non-Resident Account?**

No. This Promotion is only valid for customers opening or holding Non-Resident Indian account with ICICI Bank Ltd, India. Customers holding standalone Non-Resident Fixed Deposit/ Foreign Currency Non-Resident Account with ICICI Bank Ltd are not eligible for the promotion.
